DRAW PROCEDURE

Qualifying rounds 11th UEFA European Women's Under-17 and 17th UEFA European Women's Under-19 Championships, 2017/18

Please find below details of the coefficient calculation and draw procedure.

COMPETITION SYSTEM

Forty-six (WU17) and forty-nine (WU19) member associations will take part in the 2017/18 competitions. Forty-four (WU17) and forty-eight (WU19) teams will enter the competitions in the qualifying round and Germany at the WU17 level will join in the elite round. The final tournament host associations (Lithuania at WU17 level and Switzerland at WU19 level) qualify automatically for the final tournament.

COEFFICIENT RANKINGS

Coefficient rankings have been compiled for the 2017/18 qualifying round draws according to the following principles:

- Seasons taken into account: 2013/14, 2014/15 and 2015/16.
 - Coefficients calculated on the basis of all matches in the qualifying and elite rounds.
- Win = 3 points; draw = 1 point; defeat = 0 points.
- The following bonus points have been awarded:
 - automatic qualification for the elite round = 3 points
 - qualification from the qualifying round to the elite round = 3 points
 - qualification from the elite round to the final tournament = 3 points
- The following bonus points have also been awarded for the results obtained during the final tournaments:

- The coefficients for the 2012/13 qualifying rounds have been taken into account for the associations that have hosted a WU17 or WU19 final tournament in the previous three seasons. This includes the bonus points awarded for qualifying for the different competition phases and the bonus points shown in the table above. These associations are:
 - 2013/14: WU17 = England, WU19 = Norway
 - 2014/15: WU17 = Iceland, WU19 = Israel
 - 2015/16: WU17 = Belarus, WU19 = Slovakia
- The coefficient for each season has been calculated by taking the number of points obtained (including bonus points) and dividing the total by the number of matches.
- The three annual coefficient calculations have then been added together to produce the overall coefficient used for the rankings.
- Associations with the same overall coefficient have been separated using the following criteria in the order given:
 1. higher number of matches;
 2. higher coefficient from the most recent season, i.e. 2015/16;
 3. higher coefficient from the next two most recent seasons, i.e. 2014/15 and 2013/14;
 4. superior goal difference from the most recent season, i.e. 2015/16;
 5. superior goal difference from the next two most recent seasons, i.e. 2014/15 and 2013/14

DRAW PROCEDURE

The 44 (WU17) and 48 (WU19) associations will be split into 4 pots of 11 (WU17) and 12 (WU19) teams, as follows:

Pot A (yellow balls)

Associations ranked from 2 to 12 (WU17) / from 1 to 12 (WU19)

Pot B (red balls)

Associations ranked from 13 to 23 (WU17) / from 13 to 24 (WU19)

Pot C (green balls)

Associations ranked from 24 to 34 (WU17) / from 25 to 36 (WU19)

Pot D (blue balls)

Associations ranked from 35 to 45 (WU17) / from 37 to 48 (WU19)

The draw will start with Pot D and end with Pot A in order to ensure that the strongest teams are drawn last. Each pot will be emptied before the next pot is started.

First draw phase

- The teams in Pot D will be drawn one after another and placed in the **fourth** position in Groups 1 to 11 (WU17) and Groups 1 to 12 (WU19).

Second draw phase

- The teams in Pot C will be drawn one after another and each one placed in the **third** position in one of the 11 (WU17)/12 (WU19) groups.

Third draw phase

- The teams in Pot B will be drawn one after another and each one placed in the **second** position in one of the 11 (WU17)/12 (WU19) groups

Fourth draw phase

- The teams in Pot A will be drawn one after another and each one placed in the **first** position in one of the 11 (WU17)/12 (WU19) groups.

On the basis of previous decisions taken by the UEFA Executive Committee and the UEFA Emergency Panel, the following countries cannot be drawn into the same group: Armenia and Azerbaijan, Russia and Ukraine, Kosovo and Serbia, and Kosovo and Bosnia-Herzegovina.

For both competitions, the teams will be allocated to groups in numerical order. If clashes arise, the team drawn will be moved to the next available group. The draw continues by first filling the slot left vacant. If clashes arise in the last three or four groups, the teams will be allocated to groups appropriately.

WU17: 23 teams will qualify from the qualifying round to the elite round, i.e. the 11 group winners, the 11 group runners-up and the best third-placed team.

WU19: 24 teams will qualify from the qualifying round to the elite round, i.e. the 12 group winners and the 12 runners-up.

GROUP FORMATION FOR THE ELITE ROUND

Draws will take place to form the six groups of four teams for both competitions. The definitive draw procedures will be communicated to the associations concerned on completion of the qualifying rounds.

The six group winners and the best runner-up will qualify for their respective final tournament.

MATCH DATES

Matches in the qualifying round must be played between the following dates:

- WU17: 1 August–29 October 2017
- WU19: during one of the two FIFA women's international match periods: from 11 to 19 September or from 16 to 24 October 2017. In any case, all matches must be played by Sunday 29 October 2017.
